**Form:** Liquid

**Potential Health Effects**

**Eyes:** Irritating to the eyes  
**Skin:** Contact with the skin, especially around the face, may result in initial stinging and burning sensations, followed by numbing. This may persist for several hours.  
**Ingestion:** The product is harmful if swallowed. Symptoms of overexposure include tremors, loss of motor control, numbing, burning and tingling sensations.

### 4. FIRST AID MEASURES

**Eyes:** Flush eye(s) for 15 minutes or more- If irritation persists, consult a doctor (preferably an eye specialist) and show this SDS.  
**Skin:** Carefully remove any contaminated clothing, including footwear, and wash affected areas with plenty of soap and water. If concerned, seek medical attention.  
**Ingestion:** Rinse mouth and then drink plenty of water. Do not induce vomiting. If swallowed seek medical advice and show this SDS.  
**Inhalation:** Remove affected person from site of exposure to fresh air until recovered. If not breathing, give artificial respiration. If breathing is difficult give oxygen. Seek medical attention if symptoms persist.  
**First Aid Facilities:** If poisoning occurs, contact a doctor or Poisons Information Centre on 13 11 26 (Australia).  
**General Advice:** Remove soiled or soaked clothing immediately.

**Information for doctor:** The product has low acute oral and dermal toxicity. It is moderately toxic by inhalation and minimally irritating to the eyes and may irritate the skin. Do not administer milk, cream or other substances which contain vegetable fats, as they enhance adsorption of the active ingredient. Central nervous system stimulation can be controlled with sedation by barbiturates or similar. Reversible skin sensations (paraesthesia) may occur and ordinary skin salves have been found to be useful in reducing discomfort. Otherwise, treatment is controlled removal of exposure followed by symptomatic and supportive care.

<b>Suitable Extinguishing Media:</b>	Water spray, carbon dioxide, foam or dry chemical. Do not use a water jet from a fire hose.
<b>By-products in case of Fire:</b>	In the event of a fire the following can be released: Heating and/or combustion will generate carbon monoxide, carbon dioxide, oxides of nitrogen, hydrogen chloride and hydrogen fluoride.
<b>Further Information:</b>	Keep unnecessary persons away from the area. If safe to do so, remove intact containers, otherwise use water spray to cool them. ### 6. ACCIDENTAL RELEASE MEASURES

#### Methods for Cleaning Up/ Taking Up:

Spills: Dealing with spills has the potential to increase the risk of personal exposure- during such operations, ensure that protective clothing is worn as detailed below. Avoid contact with spilled material or contaminated surfaces. Keep people and animals away. Prevent spillage from entering drains, sewers or watercourses. If contamination thereof is unavoidable, warn the local water authority. Spills should be contained and absorbed with soil, sand, sawdust, clay, cat litter or other similar material, and once absorption is complete, this material then be placed in sealable, labeled, drums for safe disposal in an approved landfill, and in accordance with the requirements of local or State Waste Management Authorities. Alternatively, bury under at least 500mm of soil in an area away from crops, pastures, homes or water sources. To decontaminate spill area, tools and equipment, wash with a suitable solution, e.g. organic solvent, detergent, bleach or caustic, and add this material to the drums of waste already collected. Label all contents. Do not burn empty containers or product.

### 7. HANDLING AND STORAGE

<b>Advice on safe Handling:</b>	Keep out of reach of children. Avoid contact with eyes and skin. Wash hands after use, and before smoking or eating / drinking. Wash protective gear and clothing after each day's use.
<b>Advice on protection against fire and explosion:</b>	Not flammable- no special measures required.

**Product Disposal:** In accordance with local authority regulations, take to special waste incineration plant.

**Container Disposal:** Dispose of empty, used containers by triple rinsing, or preferably pressure rinsing. Add the rinsate to the spray tank or dispose of the rinsate in a disposal pit away from desirable plants and their roots and from watercourses. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return cleaned containers to a recycler or designated collection point. If not recycling, break, crush or puncture empty containers and bury in a local authority landfill. If no landfill available, bury the containers at least 500<sup>mm</sup> deep in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots.
