SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General notes

Remove affected person from the contaminated area to fresh air or well-ventilated area, providing her basic life functions and protect it from the cold or heat. Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency.

Following inhalation

Remove patient to fresh air - move out of dangerous area. If symptoms develop and persist, seek medical attention.

Following skin contact

Take off all contaminated clothing. Wash affected skin areas thoroughly with plenty of water and soap. If symptoms develop and persist, seek medical attention.

Following eye contact

Immediately flush eyes with plenty of water while keeping eyelids apart (at least 15 minutes). After 5 minutes of rinsing, remove contact lenses, if present, and continue rinsing. If irritation persists, seek professional medical attention.

Following ingestion

Do not induce vomiting! Rinse mouth thoroughly with water. Immediately consult a doctor. Show the physician the safety data sheet or label.

4.2 Most important symptoms and effects, both acute and delayed

Following inhalation

Breathing dust can irritate the respiratory tract. Coughing, sneezing, nasal discharge, labored breathing.

Following skin contact

May cause sensitisation by skin contact (symptoms: itching, redness, rashes). Contact with skin may cause irritation (redness, itching).

Following eye contact

Contact with eyes can cause irritation (redness, tearing, pain).

Following ingestion

Bromadiolone is an anticoagulant which may produce bleeding. Symptoms may be delayed for several days after exposure. In case of poisoning bleeding disorders and increased bleeding tendency may occur. In severe poisoning a strong internal bleeding can cause circulatory collapse and consequent death.

4.3 Indication of any immediate medical attention and special treatment needed

In the case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). **ADVICE FOR DOCTORS:** Bromadiolone is an indirect anti-coagulant. Phytomenadione, Vitamin K1, is antidotal. Determine prothrombin time not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.
